

The Tejon Ranch Conservancy
Tom Maloney, Executive Director



In May 2009 Tejon Ranch announced the Tejon Ranch Conservation and Land Use Agreement to permanently protect 240,000 acres of this historic property. Part of that agreement included the creation of the Tejon Ranch Conservancy with its vision "to protect, explore, understand, enhance and restore the incredible biodiversity found on the Ranch." Tom Maloney, Executive Director of the conservancy, will make a powerpoint presentation and discuss "*discoveries we have made in the first year of operation, the status of conservation plans concerning the Ranch and plans that are moving forward.*"

Tom has more than 15 years of experience as a conservationist, environmental advocate, natural resource planner and ecologist. Most recently he served as the North and Central Coast Ecoregional Director for The Nature Conservancy. He started his career on the Connecticut River as the first River Steward for the Connecticut River Watershed Council. Tom holds a BA in economics from Boston University and an MS in natural resources management from Antioch New England. He is also a birder and has been a natural history tour guide on three continents.

GREAT BACKYARD BIRD COUNT - FEB. 12-15, 2010

Looking for a free, educational activity that makes a difference? This month, join tens of thousands of people throughout the US and Canada in the **2010 Great Backyard Bird Count**. You can count birds you see in your backyard, in your neighborhood, at the park...or from anywhere you can spot birds!

Whether you are new to watching birds or an expert birder, your counts count! Your checklist will contribute valuable information for science and conservation when you enter your tally online at www.birdcount.org. Your list will help scientists understand more about how the distribution and abundance of birds are changing through time. In 2009 participants documented a huge invasion of Pine Siskins across the eastern United States. More than 94,000 checklists were completed, compared to 85,700 in 2008, and a new record for the 12 year old count

It's easy to participate...

- 1) visit www.birdcount.org for easy-to-follow instructions, including tips for identifying bird species. Download a checklist for our area
- 2) Count the birds you see, wherever you choose to count. Write down the highest number of individuals you see at one time--that way you will avoid counting any bird twice.
- 3) After at least 15 minutes of watching in one place, report your results online
- 4) You can repeat your count at the same place on each day of the GBBC. You can also visit other locations and submit separate tallies for those areas as well.

If you don't have computer access, contact Madi Elsea (322-7470), who can provide a data form for you or pick up copies at the Kern Audubon meeting on February 2nd.

This is the 12th annual GBBC and is sponsored by National Audubon Society and the Cornell Lab of Ornithology. The top 10 most commonly reported birds in the 2009 GBBC were:

AUDUBON CA SUPPORTS BALLOT MEASURE TO PROTECT STATE PARKS

Continuing its long support for California State Parks, Audubon California has endorsed the State Parks and Wildlife Conservation Trust Fund Act of 2010, a proposed statewide initiative slated for the November 2010 ballot that, if approved by voters, would provide a stable source of funding that would keep state parks open.

The State Parks and Wildlife Conservation Trust Fund Act of 2010 would ensure a dedicated and reliable funding stream for state parks through an **\$18 annual surcharge on most California vehicles**. By law, the trust fund could only be spent on state parks, urban river parkways, wildlife, natural lands and ocean conservation programs. Vehicles subject to the surcharge would receive **free, year-round admission** to all state parks. Californians will no longer pay day-use fees at any state parks.

California's 278 state parks, which include state beaches and state historic parks, are priceless public assets and a vital legacy for our children and future generations. Twice in the past two years, state parks were on the brink of being shut down. Only last-minute budget reprieves kept them open. But nearly 60 state parks will be shut down part-time or their hours of operation reduced because of this year's budget cuts, and more park closure proposals and budget cuts are expected next year.

With this announcement, Audubon California joins a coalition of supporters including the California State Parks Foundation, The Nature Conservancy, The Trust for Public Land, Sierra Club California, Save the Redwoods League, Defenders of Wildlife, Surfrider Foundation, California State Park Rangers Association, California State Lifeguard Association and Ocean Conservancy.

We need your support to ensure that this initiative is included on the November 2010 ballot. Contact your chapter board or Audubon California to add your signature to the list or to volunteer to gather signatures.

NEW BOOK IN KERN AUDUBON'S LIBRARY

"John Xantus: The Fort Tejon Letters 1857-1859"

...g conditions and hardship on the western frontier are just as interesting as the specific references to natural history of the landscape around Fort Tejon in 1858. John Xantus developed an association with Spencer Fullerton Baird, Assistant Secretary of the Smithsonian Institution, who was just beginning to build a network of scientific collectors.

John Xantus is a colorful character in his own right. Born in Hungarian Austria, he claimed to be a graduate of the Polytechnical school in Vienna. Expelled from Austria during the war with Hungary in 1848, Xantus enlisted in the US Army in 1855 due to a lack of any other job prospects. When Xantus died in 1894 at the age of 69 he had never accomplished anything so noteworthy as being a collector for Spencer Baird and the Smithsonian.

Functioning in a undeveloped landscape means that travel which we take for granted today was difficult and slow. Obtaining supplies for scientific specimen preparation was only possible with substantial effort and shipping materials in either direction to reach Fort Tejon meant travel through rugged country and occasional losses due to theft.

With the recent conservation agreements for protection of the Tejon Ranch (and the subject of Kern Audubon's February 2, 2010 program), we may have a renewed appreciation for how special this landscape was prior to extensive settlement. Consider this description of wildlife from the summer of 1857: "*We have here grizlys in great abundance, they are really a nuisance, you cannot walk out half a mile, without meeting some...*" Also "*Not very far on the plains, there are large herds of Antelopes, we have some deers, Elks, Wolves, Foxes, the Panther, wild cat, immense quantity of Badgers, & others, Porcupine, Skunk, flying squirrel, Gopher, Mole, Bats and ground squirrel really in countless numbers...*".
