(www.pbase.com/jvhigbee) **Tricolored Blackbird Colonies Fail** Thousands of Tricolored Blackbirds in northwestern Kern County have mysteriously abandoned several nesting colonies in grain fields and cattail marshes. As a result, a joint effort by U.S. Fish and Wildlife Service, Audubon California, and Kern Audubon Society to save a colony of over 50,000 birds was foiled by the whims of spring weather. The plan involved payment to a dairyman to delay harvest of his 58 acre silage

crop until the birds had fledged. A grant of \$5,000 to Kern Audubon Society from Pacific Gas and Electric Co. was matched by another donor to help reach the funding goal. According to Graham Chisholm, Audubon California's Director of Conservation, who facilitated the PG&E grant to Kern Audubon, the money will be held to possibly fund another rescue effort in the future.

Dave Hardt and Scott Frazer, of Kern National Wildlife Refuge, report that the birds had built nests and a few had laid eggs, but left the fields before any eggs hatched. The causal factors are unknown, but they believe a limited food supply, caused by unusually dry and variable weather this spring, was a major reason for the breeding failure. According to Hardt, the local Tricolored breeding population was estimated at 75,000 less than last year and a similar decline has been seen in a smaller population in southern California. Since 99% of the 250,000-300,000 birds in the world live in Kern and Tulare Counties, this trend could become catastrophic to the survival of the species.

Dr. Bob Meese, UC Davis ornithologist, who has worked with the protected bird for several years, is studying the Tricolored Blackbird populations and breeding sites in an attempt to determine just what happened.

On the other hand, it is estimated that plastic bags kill at least 100,000 birds, whales, seals and turtles every year (365 Ways to Change the World) and are an eyesore all over the landscape. So what to do?! CANVAS BAGS is the way to go, if I could just remember to put them in the car when we go shopping! It seems like a small thing to do to help the environment, but when each of us continues to do those "small" things, it adds up to making a difference, just as it does when we sitch to CFL's instead of incandescent light bulbs. It is distressing to think how many millions of those bottles end up in the landfill!

Audubon Action News Alert

- AUDUBON TESTIFIES ON WIND POWER On May 1, Audubon's Director of Conservation Policy Mike Daulton testified before Congress at a hearing entitled, "Gone with the Wind: The Impacts of Wind Turbines on Birds and Bats." Audubon supports properly-sited wind power as a necessary solution to global warming but recommends further action to ensure migratory birds are provided with adequate safeguards. On the heels of the Congressional hearing, the National Academy of Sciences released a major report on the impacts of wind power on birds and wildlife. The report rightly concludes that our challenge is to design and locate wind-power projects to minimize the negative impacts on birds.
- BIRD KILLS AT COMMUNICATIONS TOWERS Audubon joined with Defenders of Wildlife, the American Bird Conservancy, and other groups in filing comments on an FCC Notice of Proposed Rulemaking to reduce bird kills. To comply with its obligations under the National Environmental Policy Act, Endangered Species Act, and Migratory Bird Treaty Act, the FCC must adopt regulations to require analysis of the effects of its licensing and permitting actions on migratory birds. The comments, filed April 23, advocate changes such as:
 - All new and existing lit towers should use only white strobes or red strobes/blinking lights (no steady burning 0 red lights).
 - 0 Guy wires should be kept off new towers.
 - Co-location of antennae on existing towers should be encouraged. Where co-location is not possible, tower height should be less than 200' where possible
